Amendment to the TORs for Lars Soeftestad, Supras Consult,  
Dated Sept 11, 2003  
Norwegian Trust Fund 051328-MAU (TFT) / P079864  
Vendor 54493 / Contract 7126821

The TORs for Lars Soeftestad, Lead Consultant under the TFT – Technology Fosters Tradition initiative, acting for and in the name of Supras Consult, are amended hereby to explicitly allow for subcontracting of local consultants.

1. The headline preceding paragraph 17 is corrected to read :  
“(A) Administration, Management and Coordination of Activities”
2. In paragraph 17 a new subparagraph (ii) is inserted to read:  
“(ii) hiring local consultants for specific tasks, for whom the terms of reference will be established by you subject to <non-objection> of the task team leader;”
3. In paragraph 17 the (old) subparagraph (ii), “managing any staff hired to perform specific tasks, whether local or international” is deleted and replaced by the words:  
“(iii) managing staff hired to perform specific tasks for the TFT Initiative, whether local consultants hired pursuant to the preceding paragraph (ii) or by the task team leader, or international consultants;”
4. The subparagraphs (iii) and (iv) in Paragraph 17 are renumbered accordingly.

The entire Paragraph 17, as amended, therefore to read:

“(A) Administration, Management and Coordination of Activities

17. You will, in collaboration with the task team leader, be responsible for overall management. This will include, *inter alia*: (i) establishing and maintaining good working relationships between the TFT and the selected World Bank and GTZ projects, (ii) hiring local consultants for specific tasks, for whom the terms of reference will be established by you, subject to <non-objection> of the task team leader, (iii) managing staff hired to perform specific tasks for the TFT Initiative, whether local consultants hired pursuant to the preceding paragraph (ii) or by the task team leader, or international consultants; (iv) coordinating activities of intervening parties and third party projects in their effect on the Initiative and (v) contributing to the preparation of progress reports. “

All other provisions of the Terms of Reference, except as amended herein, shall remain in full force and effect. This amendment will have effect as of April 1<sup>st</sup>, 2004 upon acceptance by both parties, evidenced through their signature hereunder.
